### FURTHER NOTES

#### MINIMUM REQUIREMENTS TO FILE A PATENT APPLICATION

A **United Kingdom, European or International patent application** can be filed if we are supplied with the name of the Applicant or Applicants, a statement of the invention for which protection is sought, a description of the preferred embodiment of the invention, with drawings where applicable and the number(s), place(s) and date(s) of the basic application(s) if convention priority is claimed.

#### MINIMUM REQUIREMENTS TO FILE A TRADE/SERVICE MARK APPLICATION

A **United Kingdom or European trade/service mark application** can be filed if we are supplied with the name and address of the applicant, details of or a representation of the mark, details of the goods or services and convention particulars if any.

#### MINIMUM REQUIREMENTS TO FILE A DESIGN APPLICATION

A **United Kingdom or European Union design application** can be filed if we are supplied with the name and address of the applicant, at least one set of representations of the design, a statement of novelty if other than for the design as a whole, the name address and nationality of the designer and convention details, if any.

#### OVERSEAS FILING AND PROSECUTION COSTS

Estimates of the costs of filing and prosecuting applications in jurisdictions other than those quoted above are available on request.

#### HOURLY CHARGE RATE
